

### **Whether courses offered by CISJ are accredited by any University?**

CISJ is offering a diploma and not a degree. Hence accreditation from any university is not required.

### **Whether courses offered by CISJ are accredited by AICTE?**

AICTE stands for All India Council for Technical Education. AICTE approval is required for Technical Institutions Offering Technical Programmes, As per AICTE Act, technical institution means an institution, not being a University, which offers courses or programmes of technical education. Technical education has been defined by the Act as programmes of education, research and training in engineering technology, architecture, town planning, management, pharmacy and applied arts and crafts and such other programme or areas as the Central Government may, in consultation with the Council, by notification in the Official Gazette, declare;

CISJ is an institution offering insurance industry specific professional educational courses supported by Private Sector Companies in Insurance Industry in India. Courses offered by CISJ do not come under the ambit of definition of Technical Education Courses. Hence CISJ does not require approval from AICTE

### **What are the job prospects of CISJ programmes?**

Taking Admission in College of Insurance Studies Jodhpur is distinctive in the sense that with the joining a programme the student has chosen the career as an Insurance Professional. We have strong support of insurance industry that helps students in their placement.
